Much focus and time is currently being spent on the registry development and integrated genetics projects. We have various staff working on these projects and your board feels that the outcomes from these projects will guide in determining what is best for all associations going forward.

I would also like to thank all the staff for their dedication in working in strange times and still managing to get the job done and finally thanking all of you representing your respected associations and joining in today.

## **General Manager's Report**

To all breeders and association representatives, I am pleased to report to you on behalf of the Canadian Livestock Records Corporation (CLRC).

The Annual Meeting scheduled for April in Calgary, has again been scheduled to be held by Zoom videoconference due to Covid. However, staff have proven that working remotely is a feasible alternative, albeit not perfect. As we head into another year we will look at developing specific policies and parameters to ensure staff are in the office several days per week to address customer inquiries, quickly and efficiently.

As with most every industry, CLRC had difficulties finding and retaining qualified long term additional or replacement staffing this past year, and this remains another challenge we will address in the coming year, particularly in our systems and software department, and frontline service. Staff will continue to be outfitted with new laptops in order to be more effective and efficient working remotely.

The CLRC year-end results for 2021 are positive. The Units (work production) finished the year at - 1.7% from the previous year, close to our target, and providing a financial year-end surplus.

The budget for 2022 is presented by the Board based on projected increased expenses and investments in CLRC staffing and resources, and a slight increase of .15 cents in Unit costs. The Board and management feel the increase is necessary to ensure we can meet our aggressive goals in 2022 and beyond.

As promised at last year's Annual Meeting, the Board and Management embarked on the strategic direction of reviewing the current database system and front end delivery. As such, a Request for Proposals was developed, and we are in the final stages of reviewing if the proposals received will meet our goals. This will be presented shortly for further input from all association reps.

This project is in collaboration with another significant development. Being led by the Canadian Centre For Swine Improvement (CCSI), CLRC is a partner organization, along with the Canadian Sheep Breeders Association, the Canadian Goat Society, and the Canadian Meat Goat Association in developing an Integrated Genetic Services Project for Multiple Species. This project is funded in part by the Government of Canada under Agriculture and Agri-Food Canada's Canadian Agricultural Strategic Priorities Program.

I would like to recognize the CLRC staff who continue to work on behalf of the breed associations and individual breeders. The base team we currently have is strong, committed and looking forward to the future developments being discussed. I would also like to thank the breeders for their patience during these trying times over the last two years

Finally, I would like to thank the Board of Directors for their continued support and leadership in representing all Associations with CLRC. The Board is committed to filling any vacant position(s) with committed and effective member representatives. I believe we have a very strong team heading into 2022, and I look forward to a positive report forward.

## Rapport du directeur général

À tous les éleveurs et représentants d'associations, j'ai le plaisir de vous vous présenter ce rapport au nom de la Société canadienne d'enregistrement des animaux (SCEA).

L'assemblée annuelle prévue en avril à Calgary a de nouveau été planifiée par vidéoconférence Zoom en raison de Covid. Cependant, le personnel a prouvé que le travail à distance est une alternative réalisable, bien qu'imparfaite. Alors que nous nous dirigeons vers une autre année, nous envisagerons d'élaborer des politiques et des paramètres spécifiques pour nous assurer que le personnel est au bureau plusieurs jours par semaine pour répondre aux demandes des clients, rapidement et efficacement.

Comme dans la plupart des industries, la SCEA a eu de la difficulté à trouver et à retenir du personnel supplémentaire ou de remplacement qualifié à long terme au cours de la dernière année, et cela demeure un autre défi que nous relèverons au cours de la prochaine année, en particulier dans notre département des systèmes et des logiciels, et dans le service de première ligne. Le personnel continuera d'être équipé de nouveaux ordinateurs portables afin d'être plus efficace et efficient en travaillant à distance.

Les résultats de fin d'année de la SCEA pour 2021 sont positifs. Les unités (production de travail) ont terminé l'année à - 1,7% par rapport à l'année précédente, proche de notre objectif, et générant un excédent de fin d'exercice.

Le budget pour 2022 est présenté par le Conseil d'administration en fonction de l'augmentation prévue des dépenses et des investissements dans le personnel et les ressources de la SCEA, ainsi que d'une légère augmentation de 0,15 cent des coûts unitaires. Le conseil d'administration et la direction estiment que l'augmentation est nécessaire pour s'assurer que nous pouvons atteindre nos objectifs ambitieux en 2022 et au-delà.

Comme promis lors de l'assemblée annuelle de l'an dernier, le Conseil d'administration et la direction se sont lancés dans l'orientation stratégique consistant à examiner le système de base de données actuel et la livraison initiale. À ce titre, une demande de propositions a été élaborée, et nous en sommes aux dernières étapes de l'examen de la question de savoir si les propositions reçues répondront à nos objectifs. Celui-ci sera présenté sous peu pour que tous les représentants d'associations puissent y contribuer.

Ce projet est en collaboration avec un autre développement important. Dirigé par le Centre canadien pour l'amélioration des porcs Inc. (CCAP), la SCEA est un organisme partenaire, de concert avec la Société canadienne des éleveurs de moutons, la Société canadienne des éleveurs de chèvres et l'Association canadienne de la chèvre de boucherie, dans le cadre de l'élaboration d'un projet de services génétiques intégrés pour plusieurs espèces. Ce projet est financé en partie par le gouvernement du Canada dans le cadre du Programme des priorités stratégiques agricoles canadiennes d'Agriculture et Agroalimentaire Canada.

J'aimerais remercier le personnel du CLRC qui continue de travailler au nom des associations de races et des éleveurs individuels. L'équipe de base que nous avons actuellement est forte, engagée et prépare les développements futurs discutés. Je tiens également à remercier les éleveurs pour leur patience en ces temps difficiles au cours des deux dernières années.

Enfin, j'aimerais remercier le Conseil d'administration pour son soutien continu et son leadership dans la représentation de toutes les associations auprès de la SCEA. Le Conseil s'engage à pourvoir tout poste vacant avec des représentants des membres engagés et efficaces. Je crois que nous avons une équipe très solide à l'approche de 2022, et j'attends avec impatience un rapport positif.

### 1. STATUS AND PURPOSE OF ORGANIZATION

The Canadian Livestock Records Corporation ("the Corporation") is a non-profit organization that was established under section 35 of the Animal Pedigree Act. The Corporation is the national pedigree service for purebred and non-purebred livestock in Canada. The Corporation is a non-profit organization under the Income Tax Act and, as such, is exempt from income taxes.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations and include the following significant accounting policies:

#### Term Deposits

The Corporation initially measures its term deposits at fair value. The Corporation subsequently measures its term deposits at amortized cost, and tests for impairment when there are indicators of possible impairment.

#### Capital Assets

Capital assets are recorded at cost and amortized on the basis of their useful life using the following methods and durations:

Computer software and equipment	- 5 years straight-line basis
Office equipment	- 5 years straight-line basis

#### Intangible Assets

Intangible assets are recorded at cost and amortized on the basis of their useful life using the following methods and durations:

Website	- 5 years straight-line basis
Server	- 5 years straight-line basis

The Corporation capitalizes development costs when Management believes they will generate future benefits and that all the criteria for capitalization are met.

#### Impairment of Long-Lived Assets

When a tangible capital asset or intangible asset no longer has any long-term service potential to the Corporation, the excess of its net carrying amount over any residual value is recognized as an expense in the Statement of Operations.

#### Sick Leave

The Corporation has a sick leave policy which currently allows the payment of two days of accumulated sick leave per complete year of service to a maximum of 60 days. The payment is due to all terminated full-time employees employed for ten years or more as long as termination is not for cause. The current provision is intended to fully provide for this potential liability should all employees be eligible for the maximum pay-out.

#### Reserve Fund

The reserve fund represents an accumulation of operating surpluses and deficits less interfund transfers over the life of the Corporation. The purpose of the reserve fund is to assist in the funding of future capital outlays and to cover operating deficits. Upon withdrawal, member associations are entitled to their share of the reserve fund and are responsible for their share of a reserve fund deficit.

#### Internally Restricted Fund

The internally restricted fund ensures operating capital in the situation that employees entitled to severance payouts for accumulated sick leave, vacation or overtime, leave and there are insufficient funds in the operating budget to fully pay the amounts owing to them. The funds may be used to cover severance for employees retiring or quitting, or from necessary organizational downsizing. No amount was allocated for the year ended December 31, 2021 (2020 - \$nil).

#### Foreign Currency Translation

Monetary assets and liabilities denominated in foreign currencies are translated into Canadian dollars at exchange rates in effect at year end. Revenues and expenses are translated at the rate of exchange prevailing at the time of the transactions. Exchange gains and losses resulting from the translation of these amounts are recorded in the Statement of Operations.

#### Revenue Recognition

The Corporation follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue in the year received or receivable, if the amount to be received can be reasonably estimated and collection is reasonably assured.

All other revenues are recognized when services are rendered. Use of

#### Estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires Management to make estimates and assumptions that affect the reported amount of assets and liabilities, and contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from these estimates.

### **3. CASH**

The cash balance includes amounts belonging to unrelated groups for whom the Corporation deals with in a foreign currency. Funds of \$34,832 USD (2020 - \$25,010 USD) and \$925 CAD (2020 - \$973 CAD) are held within the Corporation's bank accounts. The corresponding trust obligation is recorded in accounts payable and accrued liabilities.

### **4. TERM DEPOSITS AND ACCRUED INTEREST**

Term deposits include a redeemable, guaranteed investment certificate earning interest at 0.40% (2020 - 0.55%) and maturing in July 2022.

**7. CEBA LOAN**

The Canada Emergency Business Account (CEBA) is an interest-free loan and \$20,000 of the loan is forgivable if the Corporation repays the loan in full on or before December 31, 2023. If the loan is not repaid by that date, the loan can be converted to a two-year term loan at an interest rate of 5%.

In May 2021, the Corporation commenced repayments of CEBA of \$2,000 per month (total of \$16,000 for the year).

## **8. CONTRACTUAL OBLIGATIONS**

The Corporation leases its premises, including common charges for utilities and waste removal, under an agreement expiring in December 2024. In addition, the Corporation leases various equipment under an agreement expiring in July 2026. Future minimum lease payments are required as follows:

## **9. FINANCIAL INSTRUMENTS**

The Corporation's financial instruments consist of cash, term deposits and accrued interest, other receivables, due from Breed Associations, accounts payable and accrued liabilities, accrued vacation pay, sick leave provision, and CEBA loan. It is Management's opinion that the fair value of these instruments is not materially different than their cost and that the Corporation is not exposed to significant credit, interest rate, foreign currency or liquidity risk.

### Credit Risk

The Corporation is exposed to credit risk in the event of non-performance by counterparties in connection with its receivables. The Corporation provides credit to its members in the normal course of its operations and assesses, on a continuous basis, these receivables on the basis of amounts it is virtually certain to receive.

### Interest Rate Risk

The Corporation is exposed to interest rate risk with respect to its interest-bearing term deposits.

### Foreign Currency Risk

At December 31, 2021, cash of \$2,587 (2020 - \$1,076) are denominated in US dollars and converted into Canadian dollars.

### Liquidity Risk

The Corporation is exposed to the liquidity risk mainly in respect of its accounts payable and accrued liabilities, accrued vacation pay, and sick leave provision.

There have not been any changes in the risks from the prior year.




### Total Pedigrees Registered 2018-2021




