We will miss Jim and we extend our condolences to his family.

Secondly I would like to thank everyone for joining today. We thought this year we would be in person and although we are through with most restrictions from COVID 19 we could not ignore the significant cost savings that having a hybrid virtual meeting provides. We have not totally gone virtual, the board will spend a couple of days together to work on strategic planning and looking at collaboration with others over the couple of days that we have together.

I would like to take the opportunity to thank Ron Black for stepping in and filling an immediate void in Jim's absence. Ron has many years of experience and was very helpful in transition of the various management responsibilities to others and continues to be a valuable resource for current management. What was planned to be a medium term solution to cover the day to day duties at CLRC with regard to management and administrative has now shifted to the possibility of being a long term solution. The contract that we have entered with the Canadian Centre for Swine improvement (CCSI) has worked very well from an efficiency standpoint as well as favorable to budget. General management, information technology (IT), and administration support is all included in the contract that we have with CCSI. This resource, in my opinion has supported the current staff at CLRC to provide a more efficient service with many compliments on customer satisfaction. Amazing what can happen when two good teams put their heads together.

On to the business of CLRC, you will see in the financial report that CLRC had a negative year financially. This is the very reason we need to focus on providing the best service that we can to keep our current associations happy and possibly attract others. I have no doubt that the team in place can achieve this. With the collaboration efforts ongoing we can also think about what efficiencies that will provide. Shared IT, administration staff, and general management will help in these cost savings. Other things like sharing office space, internet, servers, etc. will also make us more efficient. Another benefit that could come from collaboration with others is added services that can be provided by CLRC. The integrated genetic services project is a good example of how we can work on projects with others that not only provides revenue, it also is valuable to future services that we can provide.

In closing I want to thank all of my fellow board members for all their dedication in serving on the CLRC board. I would also like to thank all the staff for their flexibility and dedication with the difficult year they have had with the loss of Jim. It was amazing to see everyone pitch in and do what had to be done during these difficult times. This is my final year on the CLRC board and I wish all the success to who will serve on next year's board and also those who act as the delegates for the various associations.

Rapport du Président

General Manager's Report

It is my pleasure to welcome breeders, association representatives and guests to this year's annual meeting. Thank you for taking time to join us for this call and for your on-going support of the Canadian Livestock Records Corporation.

The past year has had a mix of positives on the business side of CLRC, with some sadness on the personal side. In March of 2022, Jim Washer went on extended leave for treatment of his cancer and unfortunately lost this battle and passed away on Jan 14, 2023. This was quite a shock for us as overall his treatments seemed to be going well and we were optimistic about his possible return later in 2023. Jim's obituary is included just after this report. Many of you have posted fond memories of Jim on the web page noted at the end of the obituary. Jim's family and his work family here at CLRC very much appreciate the condolences and kind words that you have shared.

I have been filling in for some of the General Manager's duties two days per week this past year. My daughter Brianna Sullivan has also been helping three days per week in cooperation with Julie Seibel, our Finance & Office Administrator. We'll continue to provide the support that is needed while longer term plans for management are determined.

Finding and retaining suitable employees to look after CLRC's computer systems has been a big challenge over the past three years. We are really pleased to now have Jack Tran as our Systems Programmer. Jack has been with us for almost two years and has provided essential stability. More recently, CLRC has also been collaborating with the Canadian Centre for Swine Improvement (CCSI) on computer services. This includes two days per week from Li Li, who has 20 years of programming experience with CCSI and is very familiar with pedigrees, and one day per week from Jim Groves, CCSI's Computer Services Manager. This provides Jack with the much-needed support for CLRC's computer services and has allowed us to stabilize the system and start to consider enhancements, new requests, and options for redevelopment of the system.

The registrar team has been stable, and the registrars have been working diligently this past year to catch up on a significant backlog that was created due to the challenging circumstances. We are now in a much better position without a backlog and turnaround time about half of what it was a year ago. I would like to acknowledge the efforts of Caleigh, Julie, Laura Lee, Lisa, Marin, Melanie, Mohamed, and Pamela, and also the patience and understanding of the associations and breeders. Maintaining good service is critical as we also work on options for redevelopment of the computer systems.

While many issues that we faced a year ago have been addressed, we know there is more that can be done to enhance services and reduce costs. Increasing collaboration with others is one of the ways to support this goal. CLRC has been pleased to be collaborating in a 3-year project with several other service organizations to integrate genetic services for Canadian sheep and goat breeders. Although focused primarily on sheep and goats, the longer-term goal is to extend genetic services to more species. The project has helped us to evaluate options for redevelopment of CLRC's registration system and has also helped put in place data exchange that allows sheep breeders participating in the GenOvis genetic evaluation program to do electronic registrations. Going forward, the project will also support adapting this new option for electronic registration of sheep to work for dairy goats and potentially other breeds. The project is also supporting a review of the current online registration tools for ways to make it easier for breeders and more efficient for the registrars. There are other benefits coming out of this project and much more to come. For more information about the project see the news section of the CLRC website or feel free to contact us at the CLRC office.

The volume of work processed in 2022 was down significantly due to the departure of the Speckle Park and Warmblood Horse associations. Overall, the work for other associations was comparable to 2021, but the loss of the two associations put significant pressure on the finances. A significant portion of the reduced revenue was addressed through collaboration with CCSI. This has allowed CLRC to operate with lower salary expenses on the IT support side while still addressing these needs. There has also been some additional revenue coming from the Integrated Genetic Services project. For 2023, we have budgeted for a small surplus based on the expected reduced volume and continuing collaboration with CCSI. We will also work towards opportunities to reduce expenses further by increasing the use of electronic services. This will reduce printing and mailing costs while also saving significant time for the registrars. We are also reviewing internal processes that can lead to efficiencies to make services more cost effective.

I will end with a big thank you to the CLRC Board and staff for all the support and dedication this past year. I have found it enjoyable and productive working with all of you and look forward to continued positive developments. A special thank you Dave Vandenbroek and Glen Parker who have been serving as your Board Chair during some very challenging years. Dave and Glen are finishing up their terms on the Board and we wish them all the best in their future endeavors. On behalf of everyone at CLRC, I would also like to thank David Trus and wish him well in his retirement after more than 25 years as representative of Agriculture and Agri-Food Canada, and a warm welcome to his successor, Courtney McMorris.

Rapport du directeur général

J'ai le plaisir d'accueillir les éleveurs, les représentants des associations et les invités à la présente assemblée annuelle. Merci d'avoir pris le temps de nous rejoindre pour cet appel et pour votre soutien continu à la Société canadienne d'enregistrement des animaux.

L'année écoulée a été marquée par un mélange de points positifs du côté commercial de la SCEA, avec une certaine tristesse du côté personnel. En mars 2022, Jim Washer a pris un congé prolongé pour le traitement de son cancer et a malheureusement perdu cette bataille et est décédé le 14 janvier 2023. Ce fut un choc pour nous car dans l'ensemble, ses traitements semblaient bien se passer et nous étions optimistes à propos de son possible retour plus tard en 2023. La nécrologie de Jim est incluse à la fin de ce rapport. Plusieurs d'entre vous ont affiché de bons souvenirs de Jim sur la page Web indiquée à la fin de la nécrologie. La famille de Jim et sa famille de travail ici à la SCEA apprécient beaucoup les condoléances et les aimables paroles que vous avez partagées.

J'ai rempli certaines des fonctions du directeur général deux jours par semaine au cours de la dernière année. Ma fille, Brianna Sullivan, a également aidé trois jours par semaine en collaboration avec Julie Seibel, notre administratrice des finances et de bureau. Nous continuerons à fournir le soutien nécessaire pendant que des plans de gestion à plus long terme sont déterminés.

Trouver et retenir des employés compétents pour s'occuper des systèmes informatiques de la SCEA a été un grand défi au cours des trois dernières années. Nous sommes vraiment ravis d'avoir maintenant Jack Tran comme programmeur de système. Jack est avec nous depuis près de deux ans et a fourni une stabilité essentielle. Plus récemment, la SCEA a également collaboré avec le Centre canadien pour l'amélioration des porcs (CCAP) sur les services informatiques. Cela comprend deux jours par semaine de Li Li, qui a 20 ans d'expérience en programmation avec le CCAP et connaît très bien les pedigrees, et un jour par semaine de Jim Groves, responsable des services informatiques du CCAP. Cela fournit à Jack le soutien indispensable pour les services informatiques de la SCEA et nous a permis de stabiliser le système et de commencer à envisager des améliorations, de nouvelles demandes et des options de redéveloppement du système.

L'équipe de registraires a été stable et les registraires ont travaillé avec diligence au cours de l'année écoulée pour rattraper un arriéré important créé en raison des circonstances difficiles. Nous sommes maintenant dans une meilleure position sans arriéré avec un délai d'exécution d'environ la moitié de ce qu'il était il y a un an. Je tiens à souligner les efforts de Caleigh, Julie, Laura Lee, Lisa, Marin, Melanie, Mohamed et Pamela, ainsi que la patience et la compréhension des associations et des éleveurs. Le maintien d'un bon service est essentiel car nous travaillons également sur des options de redéveloppement des systèmes informatiques.

Bien que de nombreux problèmes auxquels nous étions confrontés il y a un an aient été résolus, nous savons que nous pouvons faire davantage pour améliorer les services et réduire les coûts. Accroître la collaboration avec les autres est l'un des moyens d'atteindre cet objectif. La SCEA a eu le plaisir de collaborer à un projet de 3 ans avec plusieurs autres organismes de services pour intégrer les services génétiques aux éleveurs canadiens de moutons et de chèvres. Bien que fixé principalement sur les ovins et les caprins, l'objectif à plus long terme est d'étendre les services génétiques à d'autres espèces. Le projet nous a aidé à évaluer les options de redéveloppement du système d'enregistrement de la SCEA et a également aidé à mettre en place un échange de données qui permet aux éleveurs ovins participant au programme d'évaluation génétique GenOvis de soumettre leurs enregistrements de façon électronique.

À l'avenir, le projet soutiendra également l'adaptation de cette nouvelle option d'enregistrement électronique des ovins aux chèvres laitières et potentiellement à d'autres races. Le projet soutient également une révision des outils d'enregistrement en ligne actuels afin de les rendre plus faciles pour les éleveurs et plus efficaces pour les registraires. D'autres avantages découlent de ce projet et beaucoup plus à venir. Pour de plus amples renseignements sur le projet, consultez la section des nouvelles du site Web de la SCEA ou soyez les bienvenues à nous contacter.

Le volume de travail traité en 2022 a diminué de façon significative dû au départ des associations Speckle Park et Warmblood. Globalement, le travail pour les autres associations était comparable à 2021, mais la perte de ces deux associations a exercé une pression importante sur les finances. Une partie importante de la diminution des revenus a été résolue grâce à la collaboration avec le CCAP. Cela a permis à la SCEA de fonctionner avec des dépenses salariales moindres du côté du soutien informatique tout en répondant à ces besoins. Des revenus supplémentaires ont également été générés par le projet de services génétiques intégrés. Pour 2023, nous avons budgété un petit excédent en fonction du volume diminué prévu et de la poursuite de la collaboration avec le CCAP.

Nous chercherons également des occasions de réduire davantage les dépenses en augmentant l'utilisation des services électroniques. Cela réduira les coûts d'impression et d'envoi tout en faisant gagner un temps considérable aux registraires. Nous examinons également les processus internes qui peuvent mener à des gains d'efficacité pour rendre les services plus rentables.

Je terminerai par un grand merci au conseil d'administration et au personnel de la SCEA pour tout le soutien et le dévouement de l'année écoulée. J'ai trouvé agréable et productif de travailler avec vous tous et j'attends avec impatience des développements positifs continus. Un merci spécial à Dave Vandenbroek et Glen Parker qui ont été votre président du conseil pendant des années très difficiles. Dave et Glen terminent leur mandat au sein du conseil d'administration et nous leur souhaitons bonne chance dans leurs projets futurs. Au nom de nous tous à la SCEA, je tiens également à remercier David Trus et lui souhaiter une bonne retraite après plus de 25 ans comme représentant d'Agriculture et agro-alimentaire Canada, et une chaleureuse bienvenue à son successeur, Courtney McMorris.

1. STATUS AND PURPOSE OF ORGANIZATION

The Canadian Livestock Records Corporation ("the Corporation") is a non-profit organization that was established under section 35 of the Animal Pedigree Act. The Corporation is the national pedigree service for purebred and non-purebred livestock in Canada. The Corporation is a non-profit organization under the Income Tax Act and, as such, is exempt from income taxes.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations and include the following significant accounting policies:

Term Deposits

The Corporation initially measures its term deposits at fair value. The Corporation subsequently measures its term deposits at amortized cost, and tests for impairment when there are indicators of possible impairment.

Capital Assets

Capital assets are recorded at cost and amortized on the basis of their useful life using the following methods and durations:

Computer software and equipment	- 5 years straight-line basis
Office equipment	- 5 years straight-line basis

Intangible Assets

Intangible assets are recorded at cost and amortized on the basis of their useful life using the following methods and durations:

Website	- 5 years straight-line basis
Server	- 5 years straight-line basis

The Corporation capitalizes development costs when Management believes they will generate future benefits and that all the criteria for capitalization are met.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Impairment of Long-Lived Assets

When a tangible capital asset or intangible asset no longer has any long-term service potential to the Corporation, the excess of its net carrying amount over any residual value is recognized as an expense in the Statement of Operations.

Sick Leave

The Corporation has a sick leave policy which currently allows the payment of two days of accumulated sick leave per complete year of service to a maximum of 60 days. The payment is due to all terminated full-time employees employed for ten years or more as long as termination is not for cause. The current provision is intended to fully provide for this potential liability should all employees be eligible for the maximum pay-out.

Reserve Fund

The reserve fund represents an accumulation of operating surpluses and deficits less interfund transfers over the life of the Corporation. The purpose of the reserve fund is to assist in the funding of future capital outlays and to cover operating deficits. Upon withdrawal, member associations are entitled to their share of the reserve fund and are responsible for their share of a reserve fund deficit.

Internally Restricted Fund

The internally restricted fund ensures operating capital in the situation that employees entitled to severance payouts for accumulated sick leave, vacation or overtime, leave and there are insufficient funds in the operating budget to fully pay the amounts owing to them. The funds may be used to cover severance for employees retiring or quitting, or from necessary organizational downsizing. No amount was allocated for the year ended December 31, 2022 (2021 - \$nil).

Foreign Currency Translation

Monetary assets and liabilities denominated in foreign currencies are translated into Canadian dollars at exchange rates in effect at year end. Revenues and expenses are translated at the rate of exchange prevailing at the time of the transactions. Exchange gains and losses resulting from the translation of these amounts are recorded in the Statement of Operations.

Revenue Recognition

The Corporation follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue in the year received or receivable, if the amount to be received can be reasonably estimated and collection is reasonably assured.

All other revenues are recognized when services are rendered.

Use of Estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires Management to make estimates and assumptions that affect the reported amount of assets and liabilities, and contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from these estimates.

3. CASH

The cash balance includes amounts belonging to unrelated groups for whom the Corporation deals with in a foreign currency. Funds of 44,829 USD (2021 – 34,832 USD) and 877 CAD (2021 - 925 CAD) are held within the Corporation's bank accounts. The corresponding trust obligation is recorded in accounts payable and accrued liabilities.

4. TERM DEPOSITS AND ACCRUED INTEREST

Term deposits include a redeemable, guaranteed investment certificate earning interest at 2.40% (2021 - 0.40%) and maturing in July 2023.

7. CEBA LOAN

The Canada Emergency Business Account (CEBA) is an interest-free loan and \$20,000 of the loan is forgivable if the Corporation repays the loan in full on or before December 31, 2023. If the loan is not repaid by that date, the loan can be converted to a two-year term loan at an interest rate of 5%.

In May 2021, the Corporation commenced repayments of CEBA of \$2,000 per month. During the year, the Corporation repaid the loan in full and therefore recognized the \$20,000 forgivable portion into other revenue.

8. CONTRACTUAL OBLIGATIONS

The Corporation leases its premises, including common charges for utilities and waste removal, under an agreement expiring in December 2024. In addition, the Corporation leases various equipment under an agreement expiring in July 2026. Future minimum lease payments are required as follows:

9. FINANCIAL INSTRUMENTS

The Corporation's financial instruments consist of cash, term deposits and accrued interest, other receivables, due from Breed Associations, accounts payable and accrued liabilities, accrued vacation pay, sick leave provision, and CEBA loan. It is Management's opinion that the fair value of these instruments is not materially different than their cost and that the Corporation is not exposed to significant credit, interest rate, foreign currency or liquidity risk.

Credit Risk

The Corporation is exposed to credit risk in the event of non-performance by counterparties in connection with its receivables. The Corporation provides credit to its members in the normal course of its operations and assesses, on a continuous basis, these receivables on the basis of amounts it is virtually certain to receive.

Interest Rate Risk

The Corporation is exposed to interest rate risk with respect to its interest-bearing term deposits.

Foreign Currency Risk

At December 31, 2022, cash of \$988 (2021 - \$2,587) are denominated in US dollars and converted into Canadian dollars.

Liquidity Risk

The Corporation is exposed to the liquidity risk mainly in respect of its accounts payable and accrued liabilities, accrued vacation pay, and sick leave provision.

There have not been any changes in the risks from the prior year.

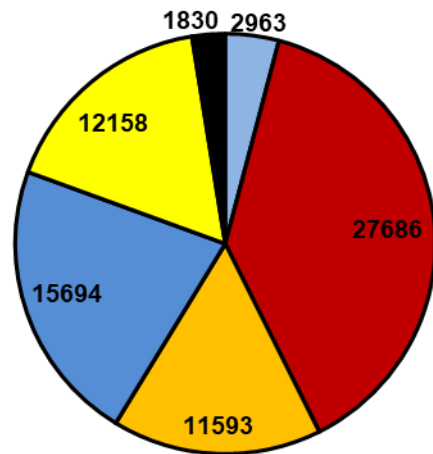


Total Pedigrees Registered 2019-2022



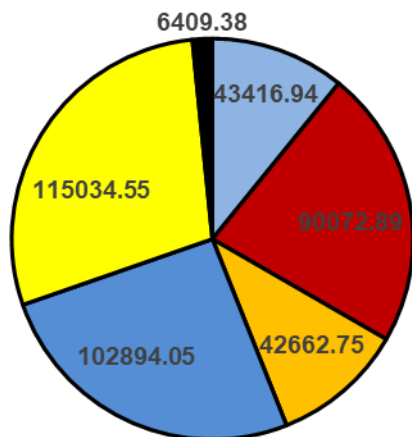
