General Manager's Report

It is my pleasure to welcome breeders, association representatives and guests to this year's annual meeting. Annual meetings are an opportunity to pause and look back at what was accomplished in the past year. It's easy to forget all the things that were done since we have a natural tendency to be focused on today's challenges and what is yet to be done. I encourage you to celebrate the accomplishments and successes, not just for CLRC, but also for your own organizations and your members.

For CLRC, 2023 was a busy and productive year. We were pleased to end the year with a positive net income and to once again budget without an increase in the levy rate for 2024. This has been possible due to increasing efficiency of internal processes, improvements to online services and more use of online services by breeders. It's important to note that you are part of this effort as you provide input, revise your bylaws and support your breeders in adapting to new processes such as the increasing use of online services. These changes have contributed to positive financial results, for example, from savings in payroll and consulting costs (down 10% from 3 years ago) and lowering of some other expenses such as postage (down 10% from 2022). This is worth celebrating and something to continue to build on. Continual improvements in efficiency and service enhancements are essential for CLRC and for the members.

Annual meetings are also an opportunity to look forward, to reflect on the purpose of the organization and the strategies to live up to that purpose. With this in mind, CLRC's Board met recently to discuss the strategic plan that was presented to members in 2017. The current directors are all new since the 2017 plan was developed, so this provided an opportunity for some independent reflection.

Understanding and agreeing on our purpose is of first and foremost importance. As indicated in the strategic plan, CLRC's vision is to provide world class animal registry services. The mission is to provide leading edge value, service and quality in sustainable registry services. It is encouraging that the current Board is in agreement with the vision and mission statements. The Board also felt that we are moving in the right direction and need to do more to ensure that CLRC lives up to these statements.

The directors overall were positive about the plan and have highlighted some areas that they feel are most important for action. Potential revisions to the plan and prioritizing actions will be a key point of focus for your new board.

It is also important for you as members to understand and agree on CLRC's purpose, and the strategies to get to where we want to be. Please take some time to have a look at the 2017 strategic plan. Rapport du directeur général

Les Assemblées générales annuelles sont l'occasion de faire une pause et de faire le point sur ce qui a été accompli au cours de la dernière année. Pour la SCEA, 2023 a été une année chargée et productive. Nous sommes heureux de terminer l'année avec un résultat net positif et de budgétiser à nouveau sans augmentation du taux de prélèvement pour 2024. Cela a été possible grâce à l'efficacité croissante des processus internes, à l'amélioration des services en ligne et à l'utilisation accrue des services en ligne par les éleveurs. Il est important de noter que vous faites partie de cet effort en fournissant des commentaires, en révisant vos règlements administratifs et en aidant vos éleveurs à s'adapter à de nouveaux processus tels que l'utilisation croissante des services en ligne. Ces changements ont contribué à des résultats financiers positifs, par exemple grâce aux économies réalisées sur la masse salariale et les coûts de consultation (en baisse de 10 % par rapport à il y a 3 ans) et à la réduction de certaines autres dépenses telles que les frais postaux (en baisse de 10 % par rapport à 2022). Cela vaut la peine d'être célébré et mérite d'être encore plus développé. L'amélioration constante de l'efficacité et du développement des services est essentielle pour la SCEA et pour les membres.

Les assemblées annuelles sont aussi l'occasion de se tourner vers l'avenir, de réfléchir à la raison d'être de l'organisation et aux stratégies à adopter pour l'atteindre. C'est dans cette optique que le conseil d'administration de la SCEA s'est réuni récemment pour discuter du plan stratégique qui a été présenté aux membres en 2017. INDEPENDENT AUDITOR'S REPORT

To the Members of Canadian Livestock Records Corporation

Opinion

We have audited the accompanying financial statements of Canadian Livestock Records Corporation ("the Corporation"), which comprise the statement of financial position as at December 31, 2023, and the statements of operations, changes in net assets, and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Corporation as at December 31, 2023, and its financial performance and its cash flows for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Corporation in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations and for such internal control as Management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, Management is responsible for assessing the Corporation's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless Management either intends to liquidate the Corporation or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Corporation's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with Canadian generally accepted auditing standards, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Corporation's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by Management.
- Conclude on the appropriateness of Management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Corporation's ability to continue as a going concern. NOTES TO THE FINANCIAL STATEMENTS

1. STATUS AND PURPOSE OF ORGANIZATION

The Canadian Livestock Records Corporation ("the Corporation") is a non-profit organization that was established under section 35 of the Animal Pedigree Act. The Corporation is the national pedigree service for purebred and non-purebred livestock in Canada. The Corporation is a non-profit organization under the Income Tax Act and, as such, is exempt from income taxes.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations and include the following significant accounting policies:

Term Deposits

The Corporation initially measures its term deposits at fair value. The Corporation subsequently measures its term deposits at amortized cost, and tests for impairment when there are indicators of possible impairment.

Capital Assets

Capital assets are recorded at cost and amortized on the basis of their useful life using the following methods and durations:

Computer software and equipment	- 5 years straight-line basis
Office equipment	- 5 years straight-line basis

Intangible Assets

Intangible assets are recorded at cost and amortized on the basis of their useful life using the following methods and durations:

Website	- 5 years straight-line basis
Server	- 5 years straight-line basis

The Corporation capitalizes development costs when Management believes they will generate future benefits and that all the criteria for capitalization are met.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Impairment of Long-Lived Assets

When a tangible capital asset or intangible asset no longer has any long-term service potential to the Corporation, the excess of its net carrying amount over any residual value is recognized as an expense in the Statement of Operations.

Sick Leave

The Corporation has a sick leave policy which currently allows the payment of two days of accumulated sick leave per complete year of service to a maximum of 60 days. The payment is due to all terminated full-time employees employed for ten years or more as long as termination is not for cause. The current provision is intended to fully provide for this potential liability should all employees be eligible for the maximum pay-out.

Reserve Fund

The reserve fund represents an accumulation of operating surpluses and deficits less interfund transfers over the life of the Corporation. The purpose of the reserve fund is to assist in the funding of future capital outlays and to cover operating deficits. Upon withdrawal, member associations are entitled to their share of the reserve fund and are responsible for their share of a reserve fund deficit.

Internally Restricted Fund

The internally restricted fund ensures operating capital in the situation that employees entitled to severance payouts for accumulated sick leave, vacation or overtime leave and there are insufficient funds in the operating budget to fully pay the amounts owing to them. The funds may be used to cover severance for employees retiring or quitting, or from necessary organizational downsizing. No amount was allocated for the year ended December 31, 2023 (2022 - \$nil).

Foreign Currency Translation

Monetary assets and liabilities denominated in foreign currencies are translated into Canadian dollars at exchange rates in effect at year end. Revenues and expenses are translated at the rate of exchange prevailing at the time of the transactions. Exchange gains and losses resulting from the translation of these amounts are recorded in the Statement of Operations.

Revenue Recognition

The Corporation follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue in the year received or receivable, if the amount to be received can be reasonably estimated and collection is reasonably assured.

All other revenues are recognized when services are rendered.

Use of Estimates

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires Management to make estimates and assumptions that affect the reported amount of assets and liabilities, and contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from these estimates.

3. CASH

The cash balance includes amounts belonging to unrelated groups for whom the Corporation deals with in a foreign currency. Funds of 37,670 USD (2022 – 44,829 USD) and 802 CAD (2022 - 877 CAD) are held within the Corporation's bank accounts. The corresponding trust obligation is recorded in accounts payable and accrued liabilities.

4. TERM DEPOSITS AND ACCRUED INTEREST

Term deposits include a redeemable, guaranteed investment certificate earning interest at 2.75% (2022 – 2.40%) and maturing in July 2024.

7. CEBA LOAN

The Canada Emergency Business Account (CEBA) is an interest-free loan and \$20,000 of the loan is forgivable if the Corporation repays the loan in full on or before December 31, 2023. If the loan is not repaid by that date, the loan can be converted to a two-year term loan at an interest rate of 5%.

In May 2021, the Corporation commenced repayments of CEBA of \$2,000 per month. During the year, the Corporation repaid the loan in full and therefore recognized the \$20,000 forgivable portion into other revenue.

8. TRANSACTIONS WITH CCSI

The Corporation has entered into an agreement with the Canadian Centre for Swine Improvement Inc. to receive management and IT support. During the year, the Corporation incurred \$119,500 (2022 – \$88,300) in related expenses.

9. CONTRACTUAL OBLIGATIONS

The Corporation leases its premises, including common charges for utilities and waste removal, under an agreement expiring in December 2024. In addition, the Corporation leases various equipment under an agreement expiring in July 2026. Future minimum lease payments are required as follows:

10. FINANCIAL INSTRUMENTS

The Corporation's financial instruments consist of cash, term deposits and accrued interest, other receivables, due from Breed Associations, accounts payable and accrued liabilities, accrued vacation pay, and sick leave provision. It is Management's opinion that the fair value of these instruments is not materially different than their cost and that the Corporation is not exposed to significant credit, interest rate, foreign currency or liquidity risk.

Credit Risk

The Corporation is exposed to credit risk in the event of non-performance by counterparties in connection with its receivables. The Corporation provides credit to its members in the normal course of its operations and assesses, on a continuous basis, these receivables on the basis of amounts it is virtually certain to receive.

Interest Rate Risk

The Corporation is exposed to interest rate risk with respect to its interest-bearing term deposits.

Foreign Currency Risk

At December 31, 2023, cash of \$2,857 (2022 - \$988) are denominated in US dollars and converted into Canadian dollars.

Liquidity Risk

The Corporation is exposed to the liquidity risk mainly in respect of its accounts payable and accrued liabilities, accrued vacation pay, and sick leave provision.

There have not been any changes in the risks from the prior year.

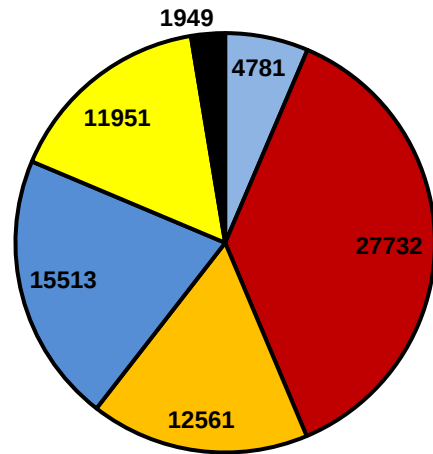


Total Pedigrees Registered 2020-2023



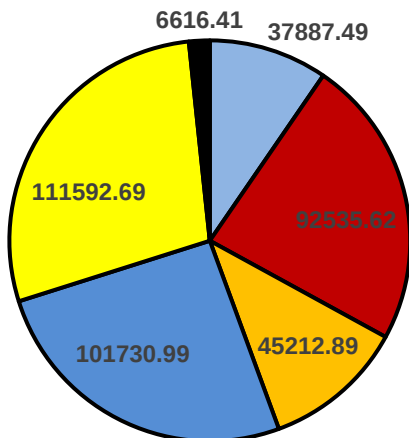
