**REGISTRATION:-**

Pertaining to Sections 1 and 2 of Article 21.

Registration of a first animal of a litter or a single fox registered on or before the 30th day of June of the year following the year of birth .....	6.00
Registration of a second and subsequent animal in a litter being registered at the same time on the same registration form.....	3.75
Each fox registered within twelve months after the 30th day of June of the year following the year of birth .....	7.50
Each fox applied for after last above mentioned date subject to the approval of the Executive Committee .....	20.00
Pertaining to Section 3 of Article 21: (Foundation Foxes)	
Each fox registered.....	25.00

**TRANSFERS:-**

Each transfer of registration of a recorded animal at the time registration is being made, within 60 days of the date of sale & delivery .....	3.25
Each transfer of an animal already registered with 60 days of the date of the sale and delivery .....	7.50
Each transfer if made after 60 days of the date of sale & delivery .....	25.00
If a fox is sold before being registered, each change of ownership is charged for at regular rate of transfer.	
Each transfer of ownership to wind up an estate, or where a father takes a son into partnership, or from a father to one of his children, or where a company changes its name or where a partnership is dissolved and a transfer made of the partnership foxes to one or more continuing partners, provided that in no case does any financial consideration pass .....	7.50
Each duplicate certificate .....	6.00
Registration of tattoo letters .....	6.00
Transfer of tattoo letters .....	6.00
Registration of name .....	6.00
Transfer of registered name.....	6.00
Registration of lease .....	7.50
Tabulated pedigrees .....	20.00
Fee for rejected applications returned to rancher because it is not completed properly .....	8.00
