

# INSTRUCTIONS

1. NAME -- Limited to 25 letters, including your REGISTERED PREFIX OR SUFFIX and spaces. Other characters such as punctuation not allowed. Names must be in Spanish or Quechua and comply with Constitution of the Peruvian Horse Association of Australasia. The BREEDER must use his/her REGISTERED PREFIX OR SUFFIX. Imported Animals must be registered with the name shown on the Foreign Certificate including prefix or suffix.
2. SEX -- Check appropriate box for gender – male, female or gelding. Provide the castration date when gelded.
3. TWINS -- Give gender of twin when applicable. If the twin is not reported on the first application, the twin will not be eligible for registration.
4. BIRTH DATE -- Write in exact date of foaling (day, month, year).
5. COLOUR -- Write in body color of foal. If turning grey or roan, record as base color + grey (i.e. Bay / Roan)  
Chestnut = red or brown tones with red, brown or flaxen mane and tail.  
Bay = red or brown tones with black mane, tail and points (lower legs, tips of ears).  
Black = Black body, mane, tail, muzzle and flanks.  
Brown = Black to very dark brown body with black mane and tail but brown shading around muzzle and flanks.  
Other colors – refer to website – buckskin, palomino, grulla, dun, cremello, perlino.
6. DESCRIPTION --
  - STAR -- A white mark on the forehead above a line running from eye to eye.
  - STRIP -- A white marking extending from the line of the eyes toward the line running from nostril to nostril.
  - SNIP -- A white or flesh mark between the nostrils or on the upper or lower lip.
  - HEEL -- A white marking found on the back of the foot.
  - CORONET -- A white marking extending to approximately 1” above the hoof.
  - PASTERN -- A white marking extending to the top of the pastern.
  - FETLOCK -- A white marking extending into the fetlock.
  - SOCK -- A white marking extending above the fetlock to midway on the cannon.
  - STOCKING -- A white marking extending above midway on the cannon.
  - DISTAL SPOT -- Pigmented spots located within white.
  - PATCH -- White marking above knee or hock, apart from face markings.
7. SIRE -- Enter full registered name, number(s) and breed. Provide Australasian reg. Number whenever possible. Stallion's DNA, Mare DNA and Foal DNA MUST be on file before registration can be issued, except in the case of the registration of a horse that is already gelded or spayed.
8. DAM -- Enter full registered name, and number(s) and breed. Provide Australasian reg. Number whenever possible. Stallion's DNA, Mare DNA and Foal DNA MUST be on file before registration can be issued, except in the case of the registration of a horse that is already gelded or spayed.
9. BREEDER -- That person who was the recorded owner or lessee of the dam at the time of SERVICE.
10. BREEDER ID -- Enter the breeder's Identification number whenever possible.
11. OWNER AT BIRTH -- That person who was the recorded owner or lessee of the dam at the time of FOALING.
12. OWNER ID -- Enter the Identification number of the owner at birth whenever possible.
13. IMPORTER -- If horse is imported from or being registered outside of Australia and New Zealand, enter name of owner.
14. IMPORTER ID -- Enter the Identification number of the importer whenever possible.
15. DATE OF IMPORTATION -- Please supply the date of importation for horses that have been imported to Australia and New Zealand.
16. SIGNATURE -- This must be the signature of the owner at birth or the importer.
17. SERVICE CERT -- Fill in the date(s) of service or insemination.
18. SIGNATURE OF STALLION OWNER -- Owner of sire at time of service to SIGN with his or her usual signature in ink. Partnership or company signatures must be countersigned by the person authorized to sign. IMPORTANT – Signatures of authorized representatives are not acceptable unless Power of Attorney is on file at Canadian Livestock Records. Stallion Service Certificate is also available as a separate form.
19. SIGNATURE OF MARE OWNER -- Owner of dam at time of service to SIGN with his/her usual signature in ink. Partnership or company signatures must be countersigned by the person authorized to sign. IMPORTANT – Signatures of authorized representatives are not acceptable unless Power of Attorney is on file at Canadian Livestock Records. Stallion Service Certificate is also available as a separate form.
20. DIAGRAM -- Draw your markings with horse in front of you in BLUE OR BLACK INK. Be sure your diagram matches the description provided in # 4. Two photos are also required, showing both sides, all legs and one with full face. Make sure the description and diagram match the photos also. Horse name to be written on back of photos.
21. DNA TYPING -- Along with this application, send the fees for registration and for DNA typing (DNA waived in the case of a gelded or spayed horse being registered). A DNA kit will be sent to you upon receipt of application and fees. If sire and dam are DNA typed by another registry, send copy of report.
22. TRANSFERS -- A transfer fee and signed transfer certificate is required if the current owner of the horse to be registered is different from the owner at birth.
